- The Authority has not made a penalty payment in over five years (69 months) and did not have any aged invoices in the October 2022 reporting period.
- The Authority currently has a total of \$132.2M in disputed invoices, which represents a \$2.3M increase in total disputes from the prior month.

- The Proposition IA cash balance increased \$67.8M month-over-month to \$111.3M and \$72.6M in bond proceeds were received in the reporting month. Cash expenditures were \$5.0M. The Authority has \$1.187B available through commercial paper, and expects the Treasurer's Office to sell Proposition IA bonds at a Spring 2023 sale.
- The Cap-and-Trade cash balance fell \$52.9M month-over-month to \$1,769.5M. No quarterly auction proceeds were credited for the month and cash expenditures were \$52.9M. Proceeds from the Aug-2022 Cap-and-Trade auction are estimated at \$205.7M for the Authority, but are not reflected in cash balances as they are still pending allocation by the Department of Finance and the State Controller's Office. The Nov-2022 Cap-and-Trade auction estimated proceeds are \$190.3M and are also pending allocation.
- The Rail Property Management Fund cash balance increased \$248,661 month-over-month to \$11.8M. Payments received totaled \$262,091 and cash expenditures were \$13,430. The Rail Property Management Fund receives revenues from leases/rents collected on Authority-owned property, and proceeds are used for property-related expenditures.

- At 33.3% of the Fiscal Year completed, \$20.3M or 21.8% of the Administrative Budget (\$93.4M) has been spent, resulting in a budget underutilization value of 11.5%. The budget underutilization is due to position vacancies and low OE&E spending.
- As of October 31, 2022, the Authority's vacancy rate is 24.0%, primarily due to 73 new state positions being added in the beginning of the 2021-22 fiscal year (Sep-21). The Authority has filled a net total of 40 positions over the past year, (from 286 to 326 filled positions).
- During the reporting month, the Authority completed recruitment for 10 vacant positions; however, the filled positions were offset by 6 separations from the Authority and 6 vacated position from internal promotions/transfers, resulting in a net decrease of 2 filled position for the reporting month.

- At 33.3% of the fiscal year completed, YTD Capital Outlay expenditures are \$333.8M or 14.5% of the fiscal year budget. The underutilization of budget is detailed in the table below.
- Construction Package Monthly Expenditures totaled \$109.8M, which includes: CP1: \$21.7M, CP2-3: \$63.6M, and CP4: \$24.5M.
- Design-Build (DB) Monthly Expenditures totaled \$97.6M, which includes: CPI: \$16.6M, CP2-3: \$60.1M, and CP4: \$20.9M.
 - Monthly expenditures Time Impact Analysis (TIA) settlement payments totaling \$11.1M, which includes: CPI (\$3.1M) and CP2-3 (\$7.9M).
- As of December 31, 2022, the percentage of DB contract dollars expended to date for each Construction Package are as follows: CP1: 64.0%, CP2-3: 64.8%, and CP4: 87.3%.

- Contracts are predominately issued for a variety of services, such as design-build and environmental work, while purchase orders are generally used to acquire goods (i.e. office supplies).
- As of October 31, 2022, the Authority had 217 active contracts and 80 active purchase orders (PO's) with a total value of \$10.3B.
- Month-over-Month the value of contracts increased by \$298.5M, primarily due to executed change orders for design-build contracts (\$291.4M), five contract amendments (\$6.3M), and 3 new contracts (\$840K).
- The Dec-22 report reflects a Small Business Utilization Rate (SBU) of 23.4%. The current rate represents a 7.2% increase from the inception of SBU reporting in Feb-15 of 16.2%.
- The Authority anticipates SBU to increase as construction activity ramps up moving closer to the SBU goal of 30%, per the Small and Disadvantaged Business Enterprise Policy approved in Aug-12.
- As of September 30, 2022, there are 739 small businesses actively working on the high-speed rail project, including 237 DBE's and 90 Certified DVBE's.
