This request is to approve a contract amendment with Westervelt Ecological Services in the amount of \$25,060,943.00 for the purchase of 1,688 acres of habitat for listed species to satisfy permit obligations. Since receiving the permits from the California Department of Fish and Wildlife and the US Fish and Wildlife Services, changes in anticipated impacts and mitigation requirements have resulted in substantial increases in required compensatory mitigation. Purchase of adequate mitigation credits is a mandatory requirement of permits to allow construction of CP2-3 and CP4.
