### **Key Topics**

- JUA and CCUA agreement requirements are not enforced consistently and third parties are asking for more than
  what is required under the Master Agreement. Coordination with JUA and CCUA parties is ongoing to mitigate
  betterment issues.
- Intrusion Protection Barrier (IPB) requirements are being reviewed by the Authority.
- BNSF track outages to perform work are very limited. Coordination with BNSF is ongoing to mitigate potential delays.
- Acquisition of several ROW parcels is critical or near critical. Mitigation measures are being considered with the Contractor, including obtaining rights-of-entry.
- California Department of Fish & Wildlife (CDFW) is concerned that embankment prevents wildlife from crossing, potentially necessitating a viaduct. Mitigation measures such as increasing the number and size of box culverts to serve as wildlife crossing structures are being considered.
- The Authority is considering the option of using welded mesh fencing in lieu of wire fencing. This may be an additional cost.
