- Vendors may appear several times due to contract amendments or multiple contracts.
- Blue shaded rows identify one contract with subsequent amendments. The contract total amount appears in bold, below the last amendment.
- Actual expenditures reflect processed and paid invoices. The encumbrance balance is reduced when payment has been completed.
- Forecasted expenditures are subject to change based on the contract manager's assessment.
