

## APPENDIX 3.14-E: WILLIAMSON ACT COMPLIANCE DATA



Table 1 shows the total acres and number of parcels of protected farmland (i.e., under Williamson Act contracts) that would be directly affected by the San Jose to Central Valley Wye Project Extent (project) alternatives in Santa Clara, San Benito, and Merced Counties.<sup>1</sup> Protected agricultural land that would be taken out of production by the project ranges from 944.4 acres under Alternative 4 to 1,042.7 acres under Alternative 3. Alternatives 1 and 2 would see intermediate acreages of protected agricultural land removed from production, at 952 acres and 956.4 acres respectively.

Tables 2a through 2d show the individual parcels under Williamson Act contracts, including those currently under contract nonrenewal,<sup>2</sup> that could be affected by each project alternative.<sup>3</sup> The tables include existing parcel size and the remainder parcel size after construction of the project. Parcels that no longer meet the minimum Williamson Act contract acreage in Santa Clara, San Benito, and Merced Counties may no longer qualify for Williamson Act contract.<sup>4</sup>

Table 3 shows the county parcel size thresholds for Williamson Act contracts for Santa Clara, San Benito, and Merced Counties.

Table 4 shows the estimated total acres and number of remainder parcels of protected farmland under each alternative. The acreage for the remainder parcels would be smaller than each county's threshold for protected farmland contracts. Agricultural land acreage protected under the Williamson Act that potentially could fall below county thresholds ranges from 797.6 acres for Alternative 4 to 890.4 acres for Alternative 3. Alternatives 1 and 2 would see intermediate acreages of remainder parcels protected agricultural land under county thresholds: 849.4 and 876 acres respectively.<sup>5</sup>

<sup>1</sup> There would be no permanent effects from implementation of network interconnections in Santa Clara, San Benito, and Merced Counties; therefore, no further discussion is required.

<sup>2</sup> The term *nonrenewal* refers to the method of terminating a Williamson Act or Farmland Security Zone contract by filing a notice of nonrenewal. The contract is terminated 10 years from the time of notice of nonrenewal. Nonrenewal can be initiated by the landowner or the local government.

<sup>3</sup> None of the three counties that would be affected by the project participate in the Farmland Security Zone program.

<sup>4</sup> Total acreages do not exactly match total acreages presented in the Agricultural Farmland Technical Report (the technical report to which this appendix is attached) or EIR/EIS Section 3.14 (Agricultural Farmland). This is because the county parcel data presented in this appendix include some road gaps and parcel overlaps at county boundaries between parcels in the detailed parcel-level analysis, whereas the acreages presented in the Agricultural Farmland Technical Report and Section 3.14 analyses are based on continuous data with no gaps for roads or overlaps at county boundaries. While the data sets do not correspond, they both are accurate calculations based on the underlying data.
